

WARRANT FOR ANNUAL TOWN MEETING

---

March 4, 1940

---

Commonwealth of Massachusetts

Norfolk, ss.

To either Constable in the Town of Norfolk, in said County,

GREETING:

You are hereby required in the name of the Commonwealth of Massachusetts to notify and warn inhabitants of the Town of Norfolk, qualified to vote in town affairs, to assemble in the Grange Hall on Monday, the fourth day of March, A. D. 1940, at 9:00 o'clock in the forenoon, then and there to act on the following articles, viz:

Article 1. To choose by ballot the following Town Officers viz: one Moderator for one year; three Selectmen, who shall act as Board of Public Welfare and Board of Health for one year; one Town Clerk, one Town Treasurer, one Collector of Taxes, one Tree Warden, three Auditors, two Constables, each for one year; one Assessor of Taxes, one Trustee of Public Library, one School Committee, each for three years; one Trustee for the Josiah Ware Fund for three years, and vote on the following question:

"Shall the operation of section one hundred and five B of Chapter one hundred and thirty-one of the General Laws, requiring for the taking of fur bearing animals the use of traps that kill at once or take alive unharmed, be suspended within this Town?"

Article 2. To hear and act on the report of the Town Officers.

Article 3. To grant and appropriate money for all necessary Town expenses, as follows, viz:

1. Schools.
2. Town Officers.
3. Public Library.
4. Memorial Day.
5. Electric Lights for the Town.
6. Bonds for Town Officers.
7. Interest.
8. Removal of Snow.
9. Public Welfare.
10. Roads.
11. Fire Department.
12. Law Enforcement.
13. Maintenance of Norfolk County Hospital.
14. General Expense.
15. Extermination of Gypsy Moth.
16. Soldiers' Relief.
17. Old Age Assistance.
18. Tree Trimming.
19. District Nurse.
20. W. P. A. Expenses.
21. Aid to Dependent Children.
22. To pay the salary of a clerk for the Selectmen.

Article 4. To see if the Town will vote to authorize the town treasurer, with the approval of the selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1940, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 5. To see if the Town will vote to raise and appropriate a sum of money to pay back bills in the Welfare Department or take any other action relative thereto.

Article 6. To see if the Town will vote to raise and appropriate a sum of money for Chapter 90 Road Work to be used with an allotment from the State and County or from either.

Article 7. To see if the Town will vote to raise and appropriate a sum of money for diphtheria immunization.

Article 8. To see if the Town will vote to extend the Electric Lights on Lincoln Road to the residence of Edmund Waitkervich and appropriate money for same, or to take any other action in relation thereto.

Article 9. To see if the Town will appropriate a sum of money to put in a passable condition that section of Tucker Road from the Medway Branch to Cleveland Street, or take any other action in relation thereto.

Article 10. To see if the Town will vote to transfer a sum of money from earnings of the town machinery fund to the machinery maintenance account to be used with the unexpended balance Dec. 31, 1939.

Article 11. To see if the Town will authorize the Selectmen to convey to the Boston Edison Company in consideration of One Dollar all its right, title and interest if any, in and to three poles and the wires and fixtures thereon on West Cedar Road, running easterly from Mirror Lake Avenue; or take any other action with respect to the subject matter.

Article 12. To see if the Town will vote to appropriate a sum of money to pay the cost of installing a street light on the last pole on Seekonk Street opposite the residence of William Cowan.

Article 13. To see if the Town will vote to appropriate a sum of money to pay the whole or any part of the cost of inoculating dogs with anti-rabic vaccine.

Article 14. To see if the Town will choose any Committee or to hear or act on the report of any Committee or Town Officer or to instruct any Committee or Town Officer.

The polls shall be opened at 9:00 A. M. and shall be closed at 7:00 P. M.

Hereof, fail not, but make return of this warrant, with your doings thereon to the Town Clerk, on or before the hour of said meeting.

## RECORD OF ANNUAL MEETING

---

March 4, 1940

---

Pursuant to the foregoing warrant, the Inhabitants met in the Grange Hall on the first Monday in March, A. D. 1940, it being the fourth day of said month.

The meeting was called to order at 8:55 o'clock A. M. by the Moderator, Arthur D. Hill, and the Warrant and Constable's return thereon were read by him.

The ballot box was examined and found to be empty. It registered 000.

The following named persons, having been appointed election officers, were sworn as such by the Town Clerk, namely, Joseph Roche, Fred Howard, Alvin J. Freeman, Arthur M. Sumner, Charles Sullivan, and Nels T. Carlson.

Douglas Rockwood was police officer.

All preliminaries required by law were complied with and the polls were declared open at 9 o'clock A. M.

The polls were declared closed at 7:00 o'clock P. M.

The ballot box registered 467 and the names checked on the voting lists and the ballots taken from the box were, upon being counted, found to agree.

Tax Collector, for one year, Charles A. DeMerritt.

Constables, for one year, Nels T. Carlson, Harold A. Hayes.

Tree Warden, for one year, Edmund T. Buckley.

RECORDS OF ADJOURNED ANNUAL  
TOWN MEETING

---

March 18, 1940

---

Pursuant to the foregoing adjournment, the Inhabitants of Norfolk, qualified to vote in Town affairs, met in the Grange Hall on Monday, March 18, 1940. The meeting was called to order by the Moderator, Arthur D. Hill, at 8 o'clock p. m. and the meeting proceeded as follows, viz:—

Article 2. Voted unanimously to accept the reports of the Town Officers as presented in the Town Reports.

Article 3. Voted to grant and appropriate the following money for the necessary town expenses, viz:—

1. Schools, thirty one thousand, two hundred dollars.
2. Town Officers, two thousand, eight hundred dollars.
3. Public Library, five hundred forty two dollars and forty nine cents, including dog tax receipts of two hundred forty two dollars and forty nine cents.
4. Memorial Day, seventy-five dollars.
5. Electric Lights, two thousand dollars.

6. Bonds for Town Officers, one hundred twenty one dollars.
7. Interest, one hundred fifty dollars.
8. Removal of Snow, three thousand one hundred dollars.
9. Public Welfare, three thousand five hundred dollars.
10. Roads, Chapter 81, four thousand, four hundred dollars.
11. Fire Department, two thousand, six hundred dollars.
12. Law Enforcement, two thousand, six hundred dollars.
13. Maintenance of Norfolk County Hospital, five hundred ninety four dollars and eighty two cents.
14. General Expense, two thousand nine hundred dollars.
15. Extermination of Gypsy Moth, six hundred sixty six dollars.
16. Soldiers' Relief, three hundred dollars.
17. Old Age Assistance, seven thousand dollars.
18. Tree Trimming, four hundred dollars.
19. District Nurse, three hundred fifty dollars.
20. W. P. A. Expenses, two thousand dollars.
21. Aid to Dependent Children, two thousand dollars.

22. Salary—Clerk for Selectmen—six hundred dollars.

Voted unanimously.

Article 5. Voted unanimously that the Town raise and appropriate the sum of five hundred dollars to pay back bills of the welfare department.

Article 6. Voted unanimously that the Town raise and appropriate the sum of two thousand dollars for Chapter 90 Road Work to be used with an allotment from the State and County or from either.

Article 7. Voted unanimously that the town raise and appropriate the sum of forty dollars for diphtheria immunization.

Article 8. Voted unanimously that the Town raise and appropriate the sum of fourteen dollars to extend the electric lights on Lincoln Road to the residence of Edmund Waitkervich.

Article 9. Voted unanimously no action be taken.

Article 10. Voted unanimously that the Town transfer the sum of two thousand, two hundred fifty dollars from the earnings of the town machinery fund to the machinery maintenance account to be used with the balance of December 31, 1939.

Article 11. Voted unanimously to deed three poles, wires, and fixtures to the Boston Edison Co.

Article 12. Voted no action be taken.

Article 13. Voted unanimously no action be taken.

Article 14. Under this article the following were voted, viz:—

1. Voted unanimously that the Board of Selectmen be instructed to take action toward reconstructing that part of Lawrence Street necessary to eliminate the blind corner opposite the Buckley and Mann factory.

2. Voted that the Moderator appoint a committee to investigate the State accounting system.

3. Voted to instruct the Selectmen to establish an Insurance account to contain all insurance of the Town.

4. Voted the By-Laws be published before the next annual meeting.

5. Voted that the Board of Selectmen be instructed to divide the sale of gasoline, oil, and accessories between the various dealers handling these articles in the Town.

Meeting adjourned at 9:10 o'clock p. m.

## PUBLIC WELFARE REPORT

---

Welfare for the year 1941 should be, if there is any change, lower than in 1940. This is due to the fact that private employment is now taking care of most of our cases. We point out, however, that several factors enter into the welfare cost over which we have very little control. Namely these are: Cases in State and County institutions, Surplus Commodities Distribution, and Norfolk cases in other towns.

We print the following from the State Department of Welfare: "The year 1940 was the largest year in the distribution of surplus commodities since this department was organized, and there was distributed in your community food valued at \$2,948.21. In addition to this allotment of food, there was distributed clothing, sheets, and blankets having a value of \$714.05. The combined value of both food and clothing for the year 1940, \$3,662.26." This amount was received in this Town for a Town cost of \$389.18.

Acting under the jurisdiction of the General Laws of Massachusetts, the Board has appointed Dr. Stagg of Medfield as Town Physician. He takes care of all welfare cases. The plan has worked out very well and insures equal treatment for every recipient.

#### W. P. A. REPORT

The W. P. A. has proven a great aid in furnishing employment for an average of 17 men for the year. We also feel that several worthwhile projects have been accomplished.

The entire year was spent on roadwork, several of the roads built by W. P. A. have already been tarred under

our regular road program and should be very little expense to the Town in the future.

During 1942, plans now call for finishing Mirror Lake Avenue and rebuilding several parts of Main Street in conjunction with our regular road program.

W. P. A. costs during 1940 were higher than in 1939 as road work is more expensive than the Hurricane Clearance projects in operation during 1939.

We also have a project in operation which is independent of the regular program. This project employs three persons and is in operation in Norfolk and Dedham. It consists of "finding the number of acres and lawful ownership of certain parcels of land in the Town of Norfolk and establishing a filing system for deeds."

Project No. 165-1-14-279, Valley Street

This project consists of rebuilding Valley Street from Route 1A to Route 115, 2,378 feet, and widen to 18 feet with necessary shoulders and drainage.

Started Dec. 3, 1940.

Expect to complete about Feb. 21, 1941.

Project No. 665-14-1-343, Mirror Lake Avenue

This project consisted of improving Mirror Lake Avenue, excavate, widen, fill, and remove trees, a distance of 870 linear feet, to a width of 20 feet with 18 feet actual road.

Started Aug. 20, 1940.

Completed Dec. 2, 1940.

Project No. 665-14-1-166, Frederickson's Road

This project consisted of rebuilding Frederickson's Road, widen, gravel, and straighten 1,600 linear feet of road, remove banks and trees to a width of 18 feet.

Started Feb. 13, 1940.

Completed Aug. 19, 1940.

Project No. 65-1-14-231, Cedar Street and Birch Road

This project consisted of improving Cedar Street and Birch Road, widen, gravel, and straighten 600 feet of Cedar Street and 1,200 feet of Birch Road to a width of 18 feet.

Started Oct. 23, 1939.

Completed Feb. 9, 1940.

The earnings of Norfolk residents, employed on W. P. A. projects anywhere in the State, for the year 1940, amounted to \$15,232.89.

Sir:

As directed by you, I have made an audit of the books and accounts of the town of Norfolk for the period from July 20, 1937, the date of the previous examination, to October 19, 1940, the following report being submitted thereon:

The records of the financial transactions of the several departments receiving or disbursing money for the town, or committing bills for collection, were examined and checked in detail.

General ledger accounts were compiled, the charges against appropriations were checked, and the appropriation accounts were compared with the town clerk's records of town meetings. A balance sheet, showing the financial condition of the town on October 19, 1940, was prepared and is appended to this report.

The books and accounts of the town treasurer were examined and checked. The cash book additions were verified, and the recorded receipts were analyzed and compared with the records of the departments making payments to the treasurer. The payments by the treasurer were compared with the selectmen's warrants authorizing the disbursement of town funds.

The treasurer's cash balance on October 19, 1940, was proved by verification of the cash in the office and by a reconciliation of the bank balance with a statement furnished by the bank in which town funds are deposited.

The recorded payments on account of temporary loans and interest were checked with the amounts falling due and with the cancelled securities on file.

The savings bank books representing the investment of the trust funds were examined and listed, the income being proved and the withdrawals being checked with the treasurer's recorded receipts.

The tax title deeds on hand were listed and the amounts transferred to the tax title account were verified. The reported redemptions were checked with the receipts as recorded on the treasurer's cash book, the foreclosures and disclaimers were verified, and the tax titles on hand were listed, proved, and compared with the records in the Registry of Deeds.

Deficits in the overlay accounts, aggregating \$734.66, and appearing on the balance sheet, should be raised by the assessors in accordance with the provisions of Section 23, Chapter 59, General Laws.

The computation of the tax rates by the assessors for the period covered by the audit was checked, and it was noted that \$2,600 appropriated September 25, 1939, from available funds was not included in the determination of the 1940 tax rate. Attention is called to Section 15A, Chapter 41, and Section 23, Chapter 59, General Laws, which must be complied with so that the tax rates may be correctly computed.

It is again recommended that the salaries of all elected officials be fixed annually by vote of the town, in accordance with the provisions of Section 108, Chapter 41, General Laws.

The books and accounts of the collector of taxes were examined and checked. The tax and assessment accounts outstanding according to the previous examination were audited and all subsequent commitments were proved. The cash books were footed and the reported collections were compared with the payments to the treasurer. The abatements, as recorded, were checked to the assessors' record of abatements granted, and the outstanding accounts were listed and proved.

The outstanding tax and assessment accounts were verified by mailing notices to a number of persons whose names appeared on the books as owing money to the town, and from the replies received thereto it appears that the accounts, as listed, are correct.

Attention is again called to the recommendations in the previous audit report that the collector's payments to the treasurer should be reported in sufficient detail, and correspond with the collections as entered in the collector's cash books, in order that the various tax levies may be properly credited on the treasurer's books.

It is again recommended that the collector make weekly payments to the treasurer of all collections as required by Section 2, Chapter 60, General Laws.

The commitments of departmental accounts receivable for temporary aid, aid to dependent children, old age assistance, and soldiers' relief were examined and checked. The recorded receipts were checked with the payments to the treasurer, and the outstanding accounts were listed and proved. It is recommended that the school department keep a record of accounts rendered for tuition and transportation in order that such accounts may be properly audited.

The town clerk's records of dog and hunting and fishing licenses issued were checked and the payments to the State and town were verified.

The surety bonds of the town officials required to file them were examined and found to be in proper form.

The records of licenses issued by the selectmen were incomplete and it is recommended that adequate records be kept of all licenses granted in order that receipts from this source may be properly audited.

The records of the library department, as well as of all other departments collecting money for the town, were examined and checked and compared with the treasurer's recorded receipts.

There are appended to this report, in addition to the balance sheet, tables showing a reconciliation of the treasurer's and the collector's cash, summaries of the tax, assessment, tax title, and departmental accounts, as well as tables showing the condition and transactions of the trust funds.

While engaged in making the audit, cooperation was received from all town officials, for which, on behalf of my assistants and for myself, I wish to express appreciation.

Article 4. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1941, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 5. To see if the Town will appropriate a sum of money for diphtheria immunization.

Article 6. To see if the Town will vote to raise and appropriate a sum of money for Chapter 90 Road Work to be used with an allotment from the State and County or from either.

Article 7. To see if the Town will appropriate a sum of money for Band Concerts.

Article 8. To see if the Town will appropriate a sum of money to clear up tax titles.

Article 9. To see if the Town will vote to install a light at the residence of Henry Nemrow and appropriate money for the same.



## REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Committee of Norfolk:

During 1940 steady progress has been made along all lines proposed a year ago. In September it was found practical to re-arrange transportation of pupils so that all second-grade children could be assembled in one room at City Mills (as last year) and all fourth-and fifth-graders in the larger room there. This segregated all the first, third, and eighth grades in single rooms at the Center, with the sixth and seventh combined in the larger room upstairs. Thus four teachers now have single grades and two only have two consecutive grades. Classes are fairly equalized and accomplish better work; pupils at City Mills are more nearly of an age, and they work and play together better than formerly, while the older ones who are better fitted for team work are together at the Center.

Only one teacher resigned at the close of the school year. Miss Olga Ahonen, after eight years with us, left to be married. We were fortunate to secure in her place Miss Olive Day, a graduate of Bridgewater Teachers College with successful experience in Westwood, who has the third grade.

The Industrial Arts shop being developed at the "Firehouse School" under direction of Mr. Roscoe Twombly has already proved of great stimulus and value to our boys. Machines added to our modest hand-tool equipment include band saw, table saw, bench grinder, drill press, and lathe. We hope soon to have a jointer and also additions to our small collection of iron-working tools. On Fridays this room is a real shop and much creditable work has been done and some put on exhibition. If we could have two

days in place of one the benefit would be tripled; let one who questions this try to build a good bookcase in two-hour periods a week apart!

Mr. Twombly has devoted the work of each class (eighth and seventh) to making two worth-while pieces of furniture, each requiring processes within the boys' power to do well but calling for their best skill and patience. They have also done repair work of school and home articles.

Through the hoped-for co-operation with other towns in our Union the Sewing has since September been conducted by Miss Olive King — a graduate of the Household Arts course at Framingham and a teacher of experience. We continue to offer this to seventh and eighth grade girls for Friday mornings only. As with the boys, much more could be accomplished if we could have two half-days in place of one, preferably on successive days. There would also be more enthusiasm and better results if we could offer cooking, home-making, correct social usage, good grooming, etc., as is being done in other towns of our Union; but until we have a place where equipment can be assembled it seems useless to consider it.

Another hope realized is the re-establishment of music supervision in our four towns. Miss Pauline Goucher, trained in Radcliffe and Boston University School of Music, makes regular Tuesday visits to Norfolk. She plans and co-ordinates the instruction in music as given by the regular teachers, teaches classes, conducts choruses, and develops standards. While our teachers during the past seven years (some specially selected for musical ability) have accomplished much, still the co-ordinating effect of one supervisor in weekly visits is already showing gratifying improvement. Musical technique, appreciation, and skill are sure to be improved. We are also resuming instrumental or orchestral music in a small way under the Harloway system of instruction.

Miss Goucher states her objectives as follows:

“The pupil's appreciation and love of good music will come through his ability to understand and sing it. Those

essentials must be learned in these first six grades. First comes voice culture, stressing the need for good tone and how to get it. Next comes an ability to read music, taught by the simplest possible method. Methods are kept easy so as not to overshadow with mechanics the third essential—an artistic interpretation of THE SONG at hand.

“In junior and senior high school our aim is good part-singing, bringing out as much genuine interest, cooperation and enjoyment as is possible among the students.”

Mrs. Judd continues her one day of instruction in Art, progressing along similar lines. Our pupils show growth in freedom of expression through crayon, brush, and pencil. More accurate seeing, finer appreciation of beauty, facility of expression are their aims.

In increasing numbers our boys go to Boston Trade School — seven last year and eight this. This may be a healthy tendency. It reflects nation-wide growth of interest in such training and demand for trained workers. It does cost the Town more than high school in Walpole or Franklin, even though the State partially reimburses us for both. It is obligatory on the Town to pay both tuition and transportation if pupils apply and the State Vocational Department approves. Some of our boys do very well; their record this fall is unusually commendable. Others do not seem to find the opportunities there worth while. To make good at Boston Trade School is harder than at high school, since the long trip is added to a long school day (partly at manual work), and exacting home preparation. No boy should attempt it unless he feels that he has aptitude for it and is willing to work hard to secure knowledge and skill. Such boys should apply; and our work in Industrial Arts should help our boys discover whether to make application.

We have been well represented, too, at Norfolk County Agricultural School. One or two of our boys have made outstanding records there. Boys well trained in any of their various courses there should find opportunities to make a good living in Norfolk.

The faithful work of our Health Department is shown in their reports, printed herewith. The activities of our eighth grade and their Class Day exercises are described by their principal. Our City Mills school, now more homogeneous in age and development, is characterized by enthusiasm and a fine spirit of co-operation. Their annual educational Saturday excursion is enjoyable and profitable. Our Center School continues to develop a remarkable student organization, led largely by older pupils and shared by even the youngest. Both schools are thus making definite contributions toward growth into real democracy — so sorely needed in every school in our land if we are to assume leadership in the world-struggle against dictatorship and for civilization.

For the loyal co-operation of all members of the School Department, including yourselves, I express my sincere thanks.

#### REPORT OF THE PRINCIPAL, CENTER SCHOOL

The limitation of space makes it necessary for me to abbreviate much that I would gladly write in a report of this nature.

In the fall we welcomed Miss Olive Day to our staff in place of Mrs. Greenwich (Miss Olga Ahonen). Miss Day has taken her assignment in fine spirit and is doing most satisfactory work in Grade III. Mr. Twombly is doing well in the shop work with the boys and we are glad to have him back again with us. Miss King is working with the girls of upper grades in Home Economics and is also a newcomer to our teaching group. I regret the difficult conditions under which she has to labor and I wish the problem might be solved as happily as that of the Manual Training. And still another teacher is Miss Pauline Goucher, Music

Supervisor. Assisted in her work by Miss Tulloch, I can already note marked progress in the musical activities of the school.

The Class Day program of the Class of 1940 was unusually well presented this past June. I appreciate sincerely the approval of our Superintendent and the School Committee relative to this annual event which is now looked forward to by the entire community. I am also pleased to note that the class of 1940 has made a very fine beginning in Walpole High School.

I feel it my duty to say that the present Center School building is inadequate in every respect for accomplishing the work of the upper three grades in particular. My personal contact with the splendid boys and girls sent to us yearly by the parents of the Town makes me wish I had the power to awaken a civic interest that would result in the construction of a modern school plant worthy of Norfolk youth and in which they could work to greater advantage.

Despite the physical handicaps of the building the spirit and vision of the teachers "marches on". They sustain their professional attitudes through the medium of their local Teachers Club, Launfoi. Weekly social activities with occasional professional meetings help us all to realize we are a unit in a great State and National effort working for the betterment and benefit of young Americans.

In behalf of the Center School teachers and myself let me again say with meaning and sincerity — we are grateful for the understanding supervision of our Superintendent and the friendly, helpful attitude of the School Committee members. This situation makes our work pleasant and easier and is a splendid example of the real joy of service when given in the spirit of cooperation with others in a common objective and cause.

The Christmas Seal Committee used part of the funds collected to provide milk for children in the schools during the year, and also paid for a very fine dental educational puppet show given by the Good Teeth Council. These two factors, nutrition and dental hygiene, are the most important of the health educational program and cannot be stressed too strongly.

The Red Cross Chapter has for years been doing a splendid piece of work with the Dental Clinic as the figures show. During the year 1940, 121 children in our schools received 100% dental cards for perfect mouths dentally. A few received theirs from their own dentists—a practice which we both commend and encourage constantly; but the clinic certainly has achieved great work and we hope it will continue. We also thank the men of the community, as the clinic received funds from dances the men ran, and funds from the firemen, which are appreciated.
