



SELECTMEN'S REPORT

Meetings: Held on 2nd and 4th Mondays at 8:00 P. M.

The new Centre School was completed in time for the opening of the fall term. We wish to thank the School Building Committee for their untiring effort in seeing the building through to completion. This committee was unpaid and their only compensation was the satisfaction of seeing the construction of a building to which the townspeople can point with pride. The school children are enthusiastic about the many modern facilities of their new building and that, as you know, is unusual. We think they actually enjoy going to school this year. We hope to complete the landscaping and to construct areas for sports and play in the rear, this coming year.

Again we call your attention to constantly rising costs of welfare and old age assistance. It seems our benevolent government plans for a comfortable old age but forgets all about the struggle of paying heavy taxes that the younger people have to go through to make this possible.

The problem of snow removal and of sanding the roads becomes greater and greater each year, as the townspeople demand more sanding of the roads. There is only one answer and that is to increase the appropriation for snow removal if they want the roads sanded like the state highways which have unlimited funds available.

Constantly rising costs of the materials and equipment we buy, plus wage increases make it more and more difficult to hold down the tax rate. This is the first year we will feel the full impact of the payment of the notes and interest on the new school. However, with the cooperation of voters at the Annual Town Meeting, and by following the suggestions of your Advisory Board, we hope that the 1951 tax rate will show only a small increase.

REPORT OF THE TOWN CLERK

For the Year Ending December 31, 1950

Proceedings Annual Town Meeting—Monday, March 6, 1950

COMMONWEALTH OF MASSACHUSETTS

At a legal meeting of the inhabitants of the Town of Norfolk qualified to vote in town affairs and elections, held in the Grange Hall, Monday, March 6, 1950, at 9:00 in the forenoon under a warrant issued by the Selectmen and dated January 3, 1950, duly attested and posted by Nels T. Carlson, a Constable of Norfolk, action was taken on the articles after the Election Officers were sworn in by the Town Clerk.

Article 1. To choose by ballot the following Town officers, viz:

One Moderator for one year—Walter T. Holmes, Myrtle St., elected.

One Selectman, for three years—Herbert A. Phelan, Union St., to act as Board of Health, elected.

One Member of Board of Public Welfare, for three years—Francis T. Dineen, Cleveland St., elected.

One Town Clerk—George F. Campbell, Main St., elected.

One Town Treasurer—Clarence S. Fuller, Rockwood Rd., elected.

One Collector of Taxes—Clarence S. Fuller, Rockwood Rd., elected.

One Tree Warden—Edmund T. Buckley, Rockwood Rd., elected.

Two Constables, each one for one year—Alvin B. Callahan, Holbrook St., elected; Nels T. Carlson, Turner St., elected.

One Assessor of Taxes for three years—Albin F. Ober, Cleveland St., elected.

One Trustee of Public Library for three years—Elizabeth A. Foss, Main St., elected.

One School Committee member for three years—Alvin J. Freeman, North St., elected.

One Water Commissioner for three years—Arthur F. Bremilst, North St., elected.

Article 2. To hear and act on the report of the Town Officers. Voted to accept the report as it stands.

Article 3. To grant and appropriate money for all necessary Town expenses as follows, viz:

1. Schools—\$56,600.00 appropriated.
2. Town Officers—\$5,070.00 appropriated.

3. Public Library—\$250.00 appropriated (plus dog tax).
4. Memorial Day—\$300.00 appropriated.
5. Electric Lights for the Town—\$2,600.00 appropriated.
6. Bonds for Town Officers—\$126.75 appropriated.
7. Removal of Snow—\$3,500.00 appropriated.
8. General Relief—\$2,000.00 appropriated.
9. Fire Department—\$3,950.00 appropriated.
10. Law Enforcement—\$3,200.00 appropriated.
11. Maintenance of Norfolk County Hospital—\$2,700.10 appropriated.
12. General Expense—\$3,000.00 appropriated.
13. Extermination of Gypsy Moth—\$675.00 appropriated.
14. Soldiers' Relief—\$1,000.00 appropriated.
15. Old Age Assistance—\$14,000.00 appropriated.
16. Tree Trimming—\$300.00 appropriated.
17. District Nurse—\$450.00 appropriated.
18. Aid to Dependent Children—\$4,000.00 appropriated.
19. To pay the salary of a clerk for the Selectmen—\$300.00 appropriated.
20. For Reserve Fund, \$2,000.00 appropriated.
21. Veterans' Administration—\$200.00 appropriated.
22. Water Dept. Notes and interest due in 1950: Voted to raise and appropriated \$3,671.21 and transfer from 1949 water revenue \$385.79.
23. Norfolk County Retirement System—\$598.10 appropriated.
24. Welfare Administration—\$600.00 appropriated.
25. Board of Health—\$1,000.00 appropriated.
26. County Tax—\$3,054.02 appropriated.

Article 4. To see if the Town will vote to authorize the Town Treasurer with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1950, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Voted unanimously that the Town Treasurer with the approval of the Selectmen be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1950, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, of the General Laws.

Article 5. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the treasury, a sum of money for Chapter 90 Highway Maintenance or take any other action in relation thereto.

Voted to raise and appropriate \$1,000.00.

Article 6. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money for Chapter 90 Highway Construction, or take any action in relation thereto.

Voted to raise and appropriate \$1,750.00.

Article 7. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury a sum of money for Chapter 81 Highways, or take any action in relation thereto.

Voted to raise and appropriate \$5,400.00.

Article 8. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money to meet School Building Notes and Interest Due in 1950 or take any other action in relation thereto.

Voted to transfer from Surplus Revenue of \$7,911.20—Principle; \$4,800.00—Interest: Total \$12,711.20.

Article 9. To see if the Town will vote to transfer from Water Revenue received in 1949, a sum of money for Water Department Maintenance, or take any other action in relation thereto.

Voted that \$2,000.00 be transferred from 1949 Water Revenue to Water Department Maintenance.

Article 10. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money to purchase a piece of fire apparatus and equipment for same, or take any other action in relation thereto.

Voted to transfer from Surplus Revenue \$6,000.00 for same.

Article 11. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money to pay land damages to the following:

Article 12. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum

of money to clear up tax titles or take any other action in relation thereto.

Voted to raise and appropriate \$100.00.

Article 13. To see if the Town will vote to fix the salaries of the elected officers or take any other action in relation thereto.

Voted to remunerate Town Officers and Appointees as follows:

Selectmen—\$600.00
Town Clerk—\$150.00 plus fees.
Town Treasurer—\$450.00.
Tax Collector—\$800.00 including water bill collections.
Assessors—\$1200.00.

Article 14. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money from the Machinery Fund to the Machinery Maintenance Account or take any other action in relation thereto.

Voted that \$2,000.00 be transferred from the Machinery Fund to the Machinery Maintenance Account.

Article 15. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money to provide quarters for the American Legion Post No. 335 or take any other action in relation thereto.

Voted to raise and appropriate \$200.00.

Article 16. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money to provide transportation to swimming classes at Franklin, for the children of Norfolk or take any other action in relation thereto.

No action taken because of lack of interest in 1949.

Article 17. To see if the Town will vote to accept the following: on all future extensions of water mains, the water takers on such extensions shall be charged an annual minimum water rate in an amount,

the aggregate of which such annual minimum water rates shall be three per cent of the cost of the extension and installation of an eight-inch line for a period of fifteen years, and that the Board of Water Commissioners be authorized to enter into contracts with such takers whereby said takers shall guarantee payment of such minimum sums for said period of fifteen years, and that all other persons desiring to connect to said extension within the fifteen-year period be obligated to pay such proportionate part of the original cost of the extension as said Board decides is fair and just, for the remainder of the fifteen-year period, provided a contract is entered into with said Board and that all contracts hereunder shall be signed and delivered to the said Board before any money shall be expended on any extension. All such contracts shall be recorded by said Board in the Registry of Deeds at Norfolk County and shall constitute a lien on the premises affected thereby, or take any other action in relation thereto.

Voted: Yes—63; No—40.

Article 18. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money to purchase a tractor and equipment for the Highway Department or take any other action in relation thereto.

Voted \$4,500.00 for same.

Article 19. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money for garbage disposal or take any other action in relation thereto.

Voted not to appropriate any sum, but that the problem be considered by the Board of Health and that they make a specific recommendation to the Town at the next Annual Town Meeting.

Article 20. To see if the Town will vote to authorize the Board of Selectmen to lease to Norfolk Post American Legion the land and buildings known as City Mills School for a term of five years at \$1.00 per year, when said school building is vacated by the School Department, or take any other action in relation thereto.

Voted favorably on this provided the property be maintained and heated at no cost to the Town.

Article 21. To see if the Town will vote to instruct the Board of Selectmen to permit the Library Committee to use as a Town Library the building known as the Old Fire Station when said building is vacated by the School Department, or take any other action in relation thereto.

Voted: Yes—73; No—61.

Article 22. To see if the Town will vote to appoint a committee to investigate and consider the advisability of the Town joining a Regional High School district, or take any other action in relation thereto.

Voted that a committee of five to include the School Committee be appointed to investigate and report to the next Annual Meeting. The committee appointed was:

Article 23. To see if the Town will vote to remove the position of Chief of Police from Civil Service subject to the affirmative vote of the State Legislature, or take any other action in relation thereto.

No action.

Article 24. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money to construct sidewalks on Rockwood Road and Main Streets around the center of town or take any other action in relation thereto.

Voted to raise and appropriate \$500.00.

Article 25. To see if the Town will vote to abandon that portion of Lake Street from Medway Street, southwesterly 2,550 feet, to the boundary of land owned by William Michelson, or take any other action in relation thereto.

Voted no.

Article 26. To see if the Town will vote to accept the following streets: Geneva Street, Malcolm Street, Ware Street, or take any other action in relation thereto.

Voted to accept:

Geneva Street—811 13/100 feet
Malcom St.—750 feet approx.
Ware St.—823 feet approx.

Article 27. To see if the Town will vote to accept the following: That in a new building development, the Board of Water Commissioners be authorized to enter into an agreement with the developer whereby the developer shall guarantee the return of 6 per cent on the original cost of the water installation for a period of 15 years, or take any action in relation thereto.

So voted.

Article 28. To see if the Town will vote to install a street light on Pole 23/23 on Everett Street in front of the residence of P. Kozak, or take any other action in relation thereto.

So voted.

Article 29. To see if the Town will vote to prohibit hunting on private land without the written permit of the owner, or take any other action in relation thereto.

Voted no.

Article 30. To see if the Town will vote to obtain water for the residents of Everett Street, Pondville, from the Town of Wrentham from a water line on Vine Street, Wrentham, or take any other action in relation thereto. (Petition)

Voted that a committee of 5 be appointed to see what could be done about getting the water. The committee is:

Article 31. To see if the Town will vote to accept the following suggested building code for the Town of Norfolk:

Sec. 1.—This by-law shall be known as the "Building Code" of the Town of Norfolk, Mass.

Sec. 2.—All new work to conform to this code. No building or structure shall hereafter be constructed, altered, or removed, or any foundation started, without obtaining a permit to build.

Sec. 3.—No building shall be sheathed, lathed, or plastered until certified by the building inspector.

Sec. 4.—The building inspector may revoke a permit after issuance in case of misstatements or misrepresentation.

Sec. 5.—No permit shall be required for any building of less than 100 square feet of floor space.

Sec. 6.—Permit shall expire one year from date of issue.

Sec. 7.—No dwelling shall be covered with any objectionable material on roof or sidewalls such as tar paper, tile, etc., except while under construction.

Sec. 8.—No shacks shall be erected except for use of contractors during construction of permanent structure. Permits for above shack shall be issued with a time limit as a temporary structure.

Sec. 9.—(a) All dwellings shall have all corner posts braced with not less than 2" x 4" braces.

(b) All dwellings shall have collar ties spaced not more than 4 ft. o. c.

(c) No privies shall be built without permission of the Board of Health.

Sec.—Fire Safeing shall comply with the Mass. Safety Code.

Article 32. To see if the Town will vote to amend Sec. 9 (a) of the present zoning laws to read as follows: No building shall be erected within 25 feet of the side line of any street, or way designated as a street or right of way on any lot plan, subdivision, or development, or within 10 feet of any side lot line.

Voted: Yes—115; No—3.

WARRANT FOR SPECIAL TOWN MEETING

May 22, 1950

At a legal meeting of the inhabitants of the Town of Norfolk, qualified to vote in Town affairs, held in the Grange Hall, Monday, May 22, 1950, at 8:00 P. M. under a warrant issued by the Selectmen and dated May 12, 1950, duly attested and posted by Nels T. Carlson, Constable of Norfolk, action was taken on the following articles:

Article 1. To see if the Town will vote to raise and appropriate by transfer from unappropriated available funds, or by a bond issue, a sum of money to install approximately 360 feet of 8" water main on Alice Road and approximately 840 feet of 6" on Walker Drive in the building development of Walfred J. Carlson. Mr. Carlson is to guarantee a minimum return from water revenue receipts of 6 per cent per annum of the cost of installation for a period of 15 years, or take any other action in relation thereto.

Voted favorable action and the transfer from Surplus Revenue of \$3,600. The developer to guarantee a minimum return from water revenue receipts of 6 per cent per annum of the cost of installation for a period of 15 years.

Article 2. To see if the Town will vote to raise and appropriate by transfer from unappropriated available funds or by a bond issue a sum of money to install approximately 880 feet of 6" water main on Ware Drive in the building development of Martin J. LeVack. Mr. LeVack is to guarantee a minimum return from water revenue receipts of 6 per cent per annum of the cost of installation for a period of 15 years, or take any other action in relation thereto.

Voted favorable action and the transfer from Surplus Revenue of \$2,640. The developer to guarantee a minimum return from water revenue receipts of 6 per cent per annum of the cost of installation for a period of 15 years.

Article 3. To see if the Town will vote to amend the zoning laws on the following described parcel of land from the present residential zoning to business zoning: A portion of the land owned by Robert C. Hall and Hilda M. Hall, said portion to be 400 ft. frontage on Rockwood Road and 150 feet depth from their parcel bounded

Northwesterly by land now or formerly of the heirs of Andrew R. Jones—164 feet more or less; northerly by Holbrook Street—634 feet more or less; easterly by land now or formerly of Thomas Glenn—128 feet more or less; southeasterly by said Glenn land—780 ft. more or less; westerly by Rockwood Road—

740 feet more or less or
take any other action in relation thereto.

Voted: No—78; Yes—0.

Article 4. To see if the Town will vote to raise and appropriate by transfer from unappropriated available funds, a sum of money for General Relief Account or take any other action in relation thereto.

Voted to raise and appropriate by transfer \$1,000.00.

Meeting adjourned and Warrant dismissed.

WARRANT FOR SPECIAL TOWN MEETING

September 20, 1950

At a legal meeting of the inhabitants of the Town of Norfolk, qualified to vote in Town affairs, held in the New Center School, Wednesday, September 20, 1950, at 8:00 P. M., under a warrant issued by the Selectmen and dated September 11, 1950 duly attested and posted by Nels T. Carlson, Constable of Norfolk, action was taken on the following articles:

Article 1. To see if the Town will raise and appropriate by transfer from unappropriated funds money for

Old Age Assistance
General Relief

Voted to raise and appropriate by transfer \$5,000.00 for Old Age Assistance and \$800.00 to General Relief.

Voted to transfer from the Sidewalk appropriation \$500.00 for the landscaping of the new school grounds.





SUMMARY REPORT OF STATE AUDIT

Mr. Francis X. Lang,
 Director of Accounts,
 Department of Corporations and Taxation,
 State House, Boston.

Sir:

As directed by you, I have made an audit of the general accounts of the town of Norfolk for the period from September 18, 1949, and of the Town Treasurer's accounts for the period from January 1, 1950, the dates of the previous examinations, to October 23, 1950, and report thereon as follows:

The financial transactions as recorded on the books of the departments receiving or disbursing money for the town or sending out bills for collection were examined, checked, and verified.

The books and accounts of the town accountant were examined and checked. The receipts as recorded were checked with the available departmental records and with the treasurer's books, while the payments were compared with the treasurer's warrants authorizing the disbursement of town funds.

The ledger accounts were analyzed for the period covered by the audit, the appropriations and transfers from the reserve fund were checked with the amounts voted by the town as shown on the town clerk's record of town meetings and with the authorizations of the advisory board, and a balance sheet which is appended to this report was prepared, showing the financial condition of the town on October 23, 1950.

The overdrawn accounts as shown on the balance sheet are contrary to the provisions of Section 31, Chapter 44, General Laws. In connection with the expenditures for Chapter 81 and Chapter 90 highway projects (shown as overdrafts on the balance sheet), attention is called to the fact that these overdrafts could have been avoided either by incurring a temporary loan as authorized by Section 6A, Chapter 44, General Laws, or by appropriating the amounts allotted by the State and County from surplus revenue with a provision that when such funds were actually received from the State and County, they be restored to the surplus revenue account.

It is recommended that the assessors notify the town accountant at least monthly of all abatements granted, as required by Section 23B, Chapter 59, General Laws.

The books and the accounts of the town treasurer were examined and checked. The recorded receipts were analyzed and verified by comparison with the records in the several departments collecting money for the town and with other sources from which money was paid into the town treasury, while the disbursements were compared with the selectmen's warrants authorizing the payments.

The cash balance on October 23, 1950, was proved by reconciliation of the bank balances with statements furnished by the banks of deposit and by actual count of cash in the office.

The payments of maturing debt and interest were proved with the amounts falling due and with the cancelled securities and coupons on file.

The records of tax titles held by the town were examined and checked. The amounts added to the tax title account were compared with the tax collector's records, the tax titles redeemed were checked with the receipts as recorded on the treasurer's cash book, and the tax titles on hand were listed and compared with the records in the Registry of Deeds.

It is again recommended that proceedings be started by the town treasurer to foreclose the rights of redemption on all tax titles held over two years, as required by law.

The savings bank books representing trust fund investments in custody of the town treasurer were examined and listed, the income being proved and the withdrawals verified.

The books and accounts of the tax collector were examined and checked. The poll and property taxes, and motor vehicle and trailer excise outstanding according to the previous examination, as well as all subsequent commitments, were audited and checked to the warrants for their collection. The payments to the treasurer were checked to the treasurer's cash book, the recorded abatements were compared with the assessors' records of abatements granted, the transfers to the tax title account were checked with the treasurer's record of tax titles held by the town, and the outstanding accounts were listed and reconciled with the respective ledger accounts.

The commitments of water charges were examined and checked. The recorded payments to the treasurer were compared with the treasurer's cash book, the abatements were checked to the commissioner's records of abatements granted, and the outstanding accounts were listed and proved to the accountant's ledger.

It is recommended that the accountant be notified promptly of all commitments made to the water collector.

Verification notices were sent to a number of persons whose names appeared on the books as owing money to the town for taxes, excise and water accounts and from the replies received thereto, it would appear that the outstanding accounts as listed are correct.

The commitments of departmental accounts receivable were examined and checked. The recorded receipts were checked with the payments to the treasurer and with the accountant's books, and the outstanding accounts were listed and proved to the accountant's ledger.

The town clerk's records of dog and sporting licenses were examined and checked, the payments to the State being verified by comparison with the receipts on file and the payments to the town being checked to the treasurer's cash book.

The surety bonds furnished by the several town officials for the faithful performance of their duties were examined and found to be in proper form.

The records of receipts from selectmen's licenses, of the sealer of weights and measures, of the library and police departments, and of all other departments collecting money for the town were examined, checked, and reconciled with the treasurer's and the accountant's books.

In the examination of the paid vouchers on file, it was noted that a bill for expenses incurred outside the Commonwealth was paid and charged to the school department appropriation for 1950. In cases of travel expenses incurred outside the State, it is recommended that payment be made from a special appropriation voted in accordance with the provisions of Clause 34, Section 5, Chapter 40, General Laws.

It was further noted that several bills of town officials for services rendered in 1949 were paid from the appropriation accounts of 1950, in which connection attention is called to the provisions of Section 64, Chapter 44, General Laws, which provides that appropriations for unpaid bills of a prior year may be voted at an annual meeting by a four-fifths vote or at a special meeting by a nine-tenths vote.

Appended to this report, in addition to the balance sheet, are tables showing a reconciliation of the treasurer's and tax collector's cash, summaries of the tax, excise, tax title, departmental and water accounts, as well as tables showing the condition and transactions of the trust funds. (On file in town offices.)

While engaged in making the audit, cooperation was received from all town officials, for which, on behalf of my assistants and for myself, I wish to express appreciation.

State budget requirements made it mandatory that we spend \$30,636.13 for Old Age Assistance to 46 people, an increase of \$3,511 over the amount spent in 1949; \$2,723.92 on Aid to Dependent Children. This Board spent \$3,784.71 for General Relief, which is entirely Town administrated.

If referendum No. 3 passed by the voters of the State of Massachusetts at the November, 1950, election becomes a law June 1, 1951, we can expect our case load and our total expenditures to at least double.

This equipment is in good mechanical repair with the exception of the two old trucks. One or both of these should be replaced as soon as possible.

The new tractor purchased in May has proven to be a great labor saver. We have used it to bulldoze and load gravel primarily, to mow the sides of the streets in town, plus the Town Hall Hill, and now are using it with its snow plow attachment.

The town now has approximately 43½ miles of road with the addition this year of the three streets in the Mart LeVack building development, namely Geneva Street, Ware Street and Malcolm Street. We hope to tar-surface these three streets this next year.

We expect to tar-surface River Road this next year, starting at the airport and continuing for approximately 1000 feet.

A good start was made on straightening Main Street. Eighteen hundred feet (1,800) of new road was constructed from Lake St. to Myrtle Street. If funds could be made available, we would like to continue this project from where we left off at Lake Street back toward the center of Norfolk for approximately 2000 feet.

We continued the effort to wipe out poison ivy along the roads and feel real progress has been made during the last few years toward permanently exterminating this plant.

The winter of 1949-1950 was very mild. We sanded and salted icy roads, and were able to handle the snow easily and keep within our appropriation.

REPORT OF THE SCHOOL COMMITTEE

To the Citizens of Norfolk the School Committee submits its Annual Report:

Regular meetings of the School Committee are held at the School Building at 7:30 P. M. on the Thursday evening before the fourth Monday of each month, except during July and August. Special meetings are also held when necessary.

Our new Norfolk Central School Building has, since the opening on September 6, 1950, contributed much to the efficiency and perfection of our school system. The new and larger classrooms offer the proper

facilities for carrying out a modern program of education and the new furnishings add much to the pleasant atmosphere of the classroom. Our school children now enjoy all of the advantages of a first class school system.

Your school committee and your superintendent are constantly striving to keep our school system abreast of the times and are advocating changes and improvements in accordance with the modern trends and techniques in education, always with due regard for the rights of all of the citizens and taxpayers. With this thought in mind we are asking for an additional appropriation this year, under a separate article for development of a much needed physical education program.

The elementary schools of Norfolk have never carried out a proper physical education program for the physical development of our children. Such a program is considered very important and is now a regular part of school activities in every modern school system. Development of strong bodies as well as strong minds are a definite obligation if we are to expect worthwhile citizens in the future.

Up to now, we have not had the adequate space needed for a good physical education program, either inside of our school buildings or playground space adjacent to our schools. We now have a large room, namely, Washburn Hall, where we can develop inside games. Our large and adequate playground space offers magnificent possibilities for sports of all kinds for our school children and our citizens.

With this thought in mind your school committee is asking for \$3500 for physical education development. These funds will be used for equipping Washburn Hall for basketball and other games, for the development of a playground at the north end of our building with certain equipment to be used, especially for the younger children. We feel that this project should have the support of all of our citizens who are interested in the continued welfare of our children. Such an investment in the youth of our town will pay large dividends in the future.

Our school budget has been carefully examined for every possible economy consistent with up to date methods in education. The increase this year is due for the most part to higher costs in High School tuition, higher costs for additional transportation and additional funds for books and supplies, which is due to the substantial increase in enrollment in our elementary school.

The School Committee wishes to express its thanks to the teaching staff for its continued loyalty and cooperation. Our staff carries out the duties of teaching with a spirit and enthusiasm, for which we all extend our heartfelt thanks and appreciation.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Committee of the Town of Norfolk:

I hereby submit my second annual report. Following this section are the reports of the Principal, Supervisors and School Nurse.

No single school report covers all the aspects of school administration. The purpose of this report is to summarize the highlights of the department during the current year.

Personnel and Plant:

For a matter of record the faculty and their assignments prior to September were as follows: Center School, Clarence E. Washburn, Principal, VIII; Miss H. Olive Day, Assistant Principal, VI and VII; Mrs. Barbara Cotten, IV; Mrs. Ruth A. Fernald, III, and Jean Gilmore, I. City Mills School, Mrs. Gertrude McBride, Principal, V; and Miss Barbara Hamilton, II.

The two one-room buildings across from the Center School were used one day each week: one for Domestic Science under the direction of Mrs. Mabel Greeley and the other for Manual Arts under the supervision of Mr. William Edwards.

Resignations were received from the following at the close of the last school year in June: Mrs. Barbara Cotten resigned to be at home; our Art Supervisor, Mr. Frederick Wellesman resigned to devote full time to Art in Westwood; Mrs. Anna Reed resigned to accept a position in a larger community.

With the increased enrollment it was deemed advisable to add to our teaching staff. For the fall term the following teachers were given contracts for the positions indicated: Mrs. Jeanne Hill, VI; Miss Mary Jane Crowley, II and III; and Miss Ann Coughlin, IV; Mrs. Eleanor Edwards, Supervisor of Music, and Mrs. Dorothy Wallace, Supervisor of Art.

The new Norfolk Central School was opened as scheduled on Wednesday, September 6, 1950. On the first day an assembly for the entire student body was conducted with Mr. Washburn, Principal, chairman for the occasion.

Your School Committee members and Superintendent were present and participated in the program.

Mr. Washburn became ill and passed away on September 19th. He had served Norfolk well for many years as Principal of the Center School. He had been conscientious, loyal, dependable, and was devoted to his school work. His passing was felt by all of us.

Through contribution of the students a plaque was erected in his honor in the All Purpose Washburn Hall.

Out of respect for Mr. Washburn, his position was not filled until November 1st. At that time Mrs. Gertrude McBride was appointed Principal and Miss Olive Day, Assistant Principal. Mrs. Alice Field was employed to teach grade eight.

Tests:

Last spring both intelligence and achievement tests were administered. Capacity to learn is measured by the intelligence tests while knowledge which has been acquired is measured by achievement tests.

Each case was treated separately. The findings are used educationally by each teacher to help serve each pupil better. It is well to add that every teacher is constantly aware of the physical, social and emotional side of the pupil. Today in education the emphasis is on boys and girls first, and then subject matter.

High School:

Last year your superintendent, with the permission and cooperation of Mr. Strout, Principal of Walpole High School, was allowed to hold conferences with the Norfolk students who were failing in one or more subjects after each marking period. With this plan, a contact was maintained for the good of the student.

The new Norfolk school offers many advantages. When two or more schools are closed and a larger unit is operated to take care of the former situation, this is known as consolidation. Therefore, the new Norfolk Central School is a consolidated school.

Some of the advantages over the former situation are, the school plant is centralized; transportation is to one point; classrooms are better lighted and more suited to the modern plan; furniture is found in every room permitting more modern technique; Washburn Hall is used for school assemblies of all kinds and it is available to the towns-

people for certain occasions. The Grange has been most cooperative for many years to allow the School Department to utilize the facilities.

The play area and athletic field when developed will be ideal for the school children and the youth of the town.

Probably one of the best visual aids for elementary schools is the 35 millimeter projector. Norfolk owns one of these and a limited amount of film strips and slides. It is our plan to add to our present supply.

Certain 16 millimeter films will also be made available for our school.

REPORT OF THE PRINCIPAL OF THE CENTRAL SCHOOL

To the Superintendent of Schools:

As I submit the first report of the Norfolk Central School, I am happy to tell you that our school program is developing into an entirely satisfactory one.

At the present time there are nine classroom teachers and four special teachers who visit our classes one day each week for Manual Arts, Music, Art and Household Arts. Each and every teacher is doing his or her best to in some way improve the standard of the school.

Washburn Hall affords facilities to carry out activities which have never before been possible. The basic idea which we try to keep in mind in all our work with student activities is that giving students opportunities to "learn by doing" is our best opportunity to develop character, good citizenship, ability to work with others and an understanding of the meaning of responsibility.

An assembly of all classes has been held in Washburn Hall once during each month since the opening of school in September. The large attendance of parents and friends at the assembly on the morning of the Dedication Day was very gratifying to the members of the faculty. Much credit must be given to the entire school personnel, to the members of the P. T. A., and to the Townspeople who so graciously assisted in many ways to make that day a splendid one for Norfolk.

All recreation periods are properly supervised by two teachers on the playground and the same number on special duty in the building. We are finding this a very satisfactory arrangement which eliminates many discipline problems.

The milk program is being carried out as usual with about one-third of the children participating. Ice cream is sold daily; any profit from the sale of ice cream will be used for the benefit of the school.

We are looking forward to an organized visual education program in the near future when we may have films and film strips to correlate with our classroom subjects.

Mr. Roy is placing much stress on the teaching of reading. He has made it possible for the teachers to hear several reading consultants give interesting and profitable lectures, and for Mrs. MacBride and Miss Day to attend sessions of the New England Reading Conference held at the Hotel Statler in November.

In closing, may I express my thanks to the members of the School Committee, to the Superintendent of Schools, to all members of the school personnel and to the parents and citizens of the town who are working together for the benefit of our children.

This is work that one should work into, gradually, if given permission to go ahead. The work, in the main, follows a need in correlation or integration with school subjects, whenever the need is felt.

REPORT OF THE MUSIC SUPERVISOR

To the Superintendent of Schools:

The program of music in all the grades consists chiefly in singing activities. This provides an outlet for self-expression and can give the children great pleasure. Other phases of music such as dancing, playing (rhythm bands and instruments), listening and creating may all be offered in the future when additional equipment and time are made available.

Children should learn to read music. They become acquainted with musical ideas in the primary grades. This approach is called reading readiness and leads naturally into the program of music reading in the intermediate grades. Part-singing is aspired to in the upper grades sometimes beginning as early as the fourth grade.

This year all the children's voices were tested and classified individually and special help was given those needing it in tone matching.

Every grade participated in the dedication program with patriotic songs and in an informal Christmas carol sing.

The music work of the seventh and eighth grades culminated in the presentation of the operetta "Pinafore."

The cooperation and support of the teachers was excellent in all the music work of this year and response of the pupils was most gratifying.

REPORT OF THE MANUAL ARTS SUPERVISOR

To the Superintendent of Schools:

The Manual Arts classes in Norfolk are not taught with the intention of making cabinet makers or carpenters of the boys. The purpose is to give an understanding of tools and their uses.

The seventh grade boys are taught the proper use and care of hand tools. Small projects that can be done by hand are built. Some of the articles made this year were: bird feeding stations, bird houses, small corner shelves, simple coffee tables, stools and one boy made a carrying box for tools.

In the eighth grade, the boys having had their training in hand tools, go on to the uses and care of power tools. They learn proper methods of cutting with the circular saw and band saw. Wood turning is a fascinating and exacting study. Some of the boys built coffee tables with turned legs, others used the lathe for rounding the ends of square legs so that they might be inserted in the bottoms of tables.

Each boy was asked to make a drawing of his project before he started the actual work of assembly. Some of the drawings were rough and out of proportion and some were well-proportioned and drawn in perspective. Some help could be given in mechanical drawing and

print reading but no time was allotted to this study. It is hoped that sometime in the future a class in mechanical drawing may be started.

A few projects were completed and taken home at Christmas. All major projects were finished by spring and some additional small projects were completed by the end of the school year.

REPORT OF THE WATER DEPARTMENT

During 1950, eight new service connections were made, bringing the total to 92. The total number of families served is slightly greater than this number, since the owners of duplex or multiple apartment buildings are presently billed on the basis of the number of units served.

The average daily requirement of water for the town was 10,300 gallons, which in turn amounts to approximately 42,000 gallons annually per water applicant.

Water, as heretofore, is supplied by the State from the Norfolk Prison Colony. Although plans have been developed to extend the prison water supply, no funds have been appropriated to fulfill such plans. Prison authorities have, therefore, requested that, particularly during periods of water shortages, that Norfolk citizens cooperate by conserving water wherever possible. This request has been observed in the past and is appreciated by the prison officials and by the Water Commissioners.

The possible shortage of water from the prison supply emphasizes the importance of planning for a potential independent source of town water. To date, exploratory drillings indicate our best source to be north of Medway Street and approximately 1000 yards east of Myrtle Street. On the basis of surveys made to date, and the indication that no immediate expansion of prison wells is contemplated, it may be advisable to consider future expansion of water mains in the direction of a suitable source of water supply.

If new construction is considered, it should be noted that under present conditions, at least four to six months should be allowed for acquisition of needed materials.

At the Annual Town Meeting, held in March, 1950, the voters voted favorably on two articles pertaining to financing of water main

extensions. One article covered extensions made along public roads; the other covered extensions made into private developments.

In accord with the latter, money was appropriated to extend mains into properties owned by Mr. W. J. Carlson on Main Street and by Mr. Mart J. LeVack off Rockwood Road. A water main was extended into the Carlson property and annual payments will be made to the town for this project. No work was started on the LeVack property pending the filing of an acceptable contractual agreement.

To either constable in the Town of Norfolk, in said County,

Greetings:

You are required in the name of the Commonwealth of Massachusetts to notify and warn inhabitants of Norfolk, qualified to vote in Town affairs, to assemble in the New School Auditorium on Monday, March 5, 1951, at 9:00 o'clock in the forenoon, then and there to act on the following articles, viz:

Article 4. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1951, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 16. To see if the Town will vote to raise and appropriate a sum of money to remodel the Old Fire Station to be used by the Library, or take any other action in relation thereto.

Article 17. To see if the Town will vote to raise and appropriate a sum of money for Civilian Defense Expenses, or take any other action in relation thereto.

Article 18. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the Treasury, a sum of money for garbage disposal, or take any other action in relation thereto.

Article 19. To see if the Town will vote to raise and appropriate or to raise by a bond issue a sum of money to extend the water main from Seekonk Street up Boardman Street, westerly an approximate distance of 1500 feet, about, to the residence of Nelson R. and Jeanne D. Hill on said Boardman Street in accordance with Article 17 passed in the town meeting of March 20, 1950, or take any other action in relation thereto. (Petition.)

Article 20. To see what disposition the Town wishes to make of the Old Center School in Norfolk, or take any other action in relation thereto.


